## Minutes of a Special Meeting of the COTTRELLVILLE TOWNSHIP BOARD

# COMPENSATION COMMISSION OF

Scheduled for Thursday, March 12th, 2009 at 7:00 p.m.

The Special Meeting was called to order by Supervisor Tom Raymond, followed by the Pledge of Allegiance at 7:01 p.m. in the Board Room of the Cottrellville Township. Roll Call attendance taken.

The booklet prepared by this Compensation Commission was passed out to each Board member, and a few minutes was allowed while they reviewed the information. After a short time, Mrs. Korpal introduced the Commission, then proceeded to explain the objective of the Commission. Mrs. Korpal explained the objective was to determine salaries for wages of officers of the township. It was explained this process began by gathering information from township resources such as the Ad-hoc Committee, historical data and MTA Surveys. To this, Personal interviews were also conducted of each elected official and insight into past practices was also explored.

Several of the other members of the Commission also spoke adding that they all agreed that the methods needed to be re-systemized. As a group they determined a foundation of duties and responsibilities was a necessary tool and a crucial part of their method of recommendation.

It was explained by the members they did not take this job lightly as their committee met six times for at least two hours per meeting for the past 45 days as was required by their Commission.

The Compensation Commission provided background and clarification to the Township Board.

Members of the Commission advised the proposals cover statutory and nonstatutory duties. They suggested job descriptions, duties/responsibilities be reviewed by the Board and updated if necessary on an annual basis. The Commission assumed mileage, meals (if required), and lodging (if required), and necessary incidental expenses would be reimbursed for essential meetings.

The Commission proposed salaries that assumed no non-statutory hourly pay for essential meetings, and assumed no non-statutory hourly pay for travel time. The commission took no position on per diem pay.

The Compensation Commission, with this Proposal, advised Board members that they made an effort to "normalize" Cottrellville elected officials' salaries and establish a baseline for the future.

The Township Board members began questioning some of the duties and agreed with most of the descriptions that were provided.

After much discussion, the following items were changed in the description of duties:

Under SUPERVISOR, CLERK & TREASURER: From the heading *Non-Statutory duties, board approved:* Remove the wording "Water Districts 2,3,4 & New or Proposed water districts."

It was also added to the Supervisor's description, in conjunction with the above noted change, that "in the case of current and/or future water district projects, other special assessment projects, or any future project that requires extra time, that a separate administrative fee will be established. The additional compensation for this work shall be paid to the Supervisor, and his Office, as well as the Assessor and Assessing Department. Said fee will be added to the cost estimate of the project or

Special Assessment at hand."

Under CLERK, change the line in *Responsibilities/Duties/job* description data, support for compensation commission recommendations: to read "Prepares warrants and township checks."

Under TREASURER, change the line in Responsibilities/ Duties/Job Description data, support for Compensation Commission recommendations to read "prepares tax township checks" and add a line to say: "Verifies, signs and distributes township checks."

Also under **TREASURER**, change the line in *Non-Statutory duties*, board approved 2008 Budget, to **read** "**Second Tax Collections & distribution**, **identified as non-statutory**" removing the word "summer," and replace it with "Second."

There were no changes indicated in the **TRUSTEE** descriptions.

The following recommendations were provided as salaries for the following Members of the Cottrellville Township Board:

SUPERVISOR	. \$26,000.00 annually per year
CLERK	. \$22,000.00 annually per year
TREASURER	. \$22,000.00 annually per year
TRUSTEE	\$ 2.500.00 annually per year

Supervisor Raymond concurred with her suggestion and advised that he would look after this for her, thanking all members present for their cohesion and success in completing their goal objective.
